Qualifying Work Experience

What do the SQE exams involve?

SQE 1

SQE 1 focuses on 'functioning legal knowledge' by testing application of law based on realistic client-based scenarios in multiple choice questions.

There are two lengthy multiple choice papers of 180 questions each, covering all aspects of the SQE 1 syllabus.

SQE 1 must be passed before being eligible to sit the SQE2 assessments.

SQE 2

SQE 2 will test the practical legal skills required for practice, including:

- Interviewing (with written attendance note/legal analysis)
- Advocacy
- Legal research
- Legal drafting
- Legal writing
- Case and matter analysis

We have embraced the transition to the SQE as an opportunity to capitalise on inclusivity and access into a career in law. With this in mind, you will have the option to undertake one of three different pathways before you join the firm for two years of QWE, as set out in the table below.

Graduate apprenticeship (block learning)	Whilst technically an apprenticeship, you will spend one year studying full-time, completing modules similar to those on the LPC, as well as additional content to prepare for the SQE exams. You will undertake just the SQE 1 exam at the end of your studies. As an Apprentice, you will be employed by the firm during your studies, so will receive an apprentice rate salary. You will then join the business to undertake two years' QWE. You will prepare for and take the SQE 2 exams one year into your QWE, which will involve taking 4 weeks out of the business.
